Tourist Visa Requirements

- A valid international passport (the validity of the passport has to exceed the end of the proposed trip by at least three months); + 1 copy Passport + 1 copy national ID-card.
- 1 visa application form + 4 recent photographs with **white** back ground see below.
- Copy of CNIC
- An original invitation letter from a travel agency (with verifiable references in Belgium);
- Proof of employment and proof of leave;
- Air ticket reservation (**minimum 1 mont before**)
- AIG Insurance
- A hotel reservation + 1 copy
- A detailed tourist program for the stay in Belgium;
- Proof of sufficient financial means during the stay;
 - Credit card + 1 copy
 - Personal salary slips (3 months)
 - Personal bank account statements (6 months)
- Visa fee: 60 Euro /-
- Service charges: Rs. 1500/-
- FedEx charges: Rs. 2180/-



Business Visa Requirements

- (A valid international passport (the validity of the passport has to exceed the end of the proposed trip by at least three months); + 1 copy of the passport + 1 copy of national ID-card
- 1 visa application form + 4 recent photograph with **white** back ground see below.
- Copy of CNIC
- An original invitation letter from a company established in Belgium along with proof of previous commercial operations, if applicable.
- Proof of employment and a covering letter from the employing company or organisation explaining the aims of the applicant's visit to Belgium;
- Air ticket reservation (**minimum 1 mont before**)
- Proof of sufficient financial means:
 1. Personal
 - Credit card ; + 1 copy
 - Personal salary slips (3 months)
 - Personal bank account statements (6 months)

AND/OR

 2. Invitation letter from the Belgian company mentioning that they will take full charge of all the expenses;

Additional documents may, where appropriate, be required. Presentation of a complete file does not necessarily mean that a visa will be issued. Applications have to be transmitted minimum four weeks before the actual travel date.

Visa application files have to be forwarded to the Embassy in Islamabad through FedEx Visa Drop Box facilities. Applications can only be lodged on appointment at the Visa Section of the Embassy

Note:

- Visa applicants who are not Pakistani citizens have to present a residence permit and a re-entry visa to Pakistan valid for at least 3 months after the expiry date of the Schengen visa;
- For minors (under 18) a parental permission
